





The total cryptocurrency market capitalization amounted to \$370 billion as of March 13, 2018. Due to its specifics, it is impossible to determine the volumes of the Ukrainian cryptocurrency market. Moreover, there is no comprehensive analysis of its volumes. The BRDO is [launching](#) a review of the cryptocurrency market in Ukraine and encourages all those who are concerned about this topic to join.



Over the past 10 years, there have been no insurance contracts for 47.5% of compulsory insurance (CI) types concluded and no insurance provided. The BRDO is [launching](#) a review of this segment. According to the results of our research, our experts will propose the criteria, by which it should be applied, as well as the rules and ways to implement the best international practices.



The BRDO initiated the development of a one-in two-out model concept for its potential use in Ukraine. At that moment, experts are working on the concept that would provide for introducing this model at the level of the Cabinet of Ministers and subordinate acts at first. If everything works fine, we will initiate the transition to the legislative level.

OUR ACHIEVEMENTS:

The Verkhovna Rada supported the draft law No.7085 developed jointly with BRDO experts in the first reading! If the law is adopted, finished construction facilities will obtain assigned addresses within 5 working days instead of 10-18, and construction project owners will no longer need to go through time consuming bureaucratic procedures and register documents.

The Verkhovna Rada Committee on Economic Policy approved the draft law No.8124! The draft law No.8124 jointly developed by the Ministry of Economic Development and Trade of Ukraine and the BRDO Office will provide Ukraine with 32 positions in the Doing Business rating, \$10 billion of potential investments and the formalization of activities of 15% of entrepreneurs.

The government approved a decision that would allow the combined use of construction standards developed on the basis of national technological traditions and construction standards harmonized with regulatory documents of the European Union. These changes will create opportunities for building modern production facilities, hotels, infrastructure facilities and stadiums.
